# May 2, 2023 Levy

#### Combination Levy — 6.9 mills

- 5.4 mill operating levy
- 1.5 mill permanent improvement levy

  - o <u>Priority Maintenance Plan</u>

Home Market Value	Cost Per Month
\$100,000	\$20.13
\$200,000	\$40.26
\$300,000	\$60.39

The levy cost is based on the market value of a home, as assessed by the Hamilton County Auditor.

# Why a Levy and Why Now?



#### Deficit Spending

- Current Operating Fund Forecast
- FHSD entered deficit spending in the 2022-2023 school year. A negative cash balance is projected to occur by 2026 if the trend is not stabilized.

#### House Bill 920

- HB 920 prevents inflationary adjustments to voted levies. The last time the district requested new money was in 2019. Funds from that levy have not kept pace with inflation, rising wages for high performing staff, utilities and maintenance costs.
  - 2023 Residential Tax Rate
- Many school districts across the state ask voters for tax levies every few years in order to maintain normal operations.

#### Combination Levy

 The permanent improvement levy will allow FHSD to begin chipping away at the most projects and create a plan to meet additional needs over time. critica

## District Benchmarks



#### Cupp Report FY22

 ODE report that provides data values for more than 60 variables and also includes two columns of comparison data values – one for similar districts and one for the state.

#### Similar Districts FY22

- Twenty school districts identified by ODE as most similar to FHSD based on enrollment and demographic data.
- Comparisons with Hamilton County and Nearby Warren County districts
  - Cost Per Pupil (Source: ODE Cupp Report)
  - Residential Tax Rates—2023 (Source: County Auditors)
  - Hamilton County Comparison Data (Tax Rate, CPP, % Spent in Classroom, Performance Index)

#### Performance Index

The Performance Index is a calculation that measures student performance on the Ohio State Tests.
 (Source: Ohio Report Card data)

#### Return on Investment

 Comparison of Cost Per Pupil and Performance Index for Hamilton County School Districts. No district in Hamilton County has a better performance with a lower cost per pupil.

## Year-Over-Year Reductions



Goal: Make FHSD as lean as possible, while maintaining a high level of performance and support.

#### **Current Actions**

- \$750,000 in reductions prior to 2023-2024 school year
  - These will happen whether the levy passes or fails.

#### **Past Efforts**

\$2.7 million in reductions since 2018

## Levy Passage: What It Means



#### Maintain Current Educational Standards

- No new programs or costs, but FHSD will be able to offer the same high-quality educational opportunities to students
- Keep class sizes at similar levels
- Maintain similar offerings in music, media and gifted programs

#### Address Critical Maintenance/Repair Needs

- The PI levy will set aside much needed money for capital improvement projects.
- These funds are required by law to be used for any property, asset or improvement with an estimated life or usefulness of five years or more.
- This will allow FHSD to address things like building updates, roofs, parking lots, heating and cooling systems, or new buses or technology.

# Levy Failure: Impact on Education



#### Larger Class Sizes

 The reduction of teachers at the secondary level will likely cause an increase of average class sizes in listed subject areas.

#### Less Robust Personalized Learning

 Phase 2 reductions limit FHSD's ability to align and collaborate between buildings to deliver current levels of personalized learning and curriculum to students across all grade levels.

#### Reduced Support Services

- Fewer students will be able to receive intervention services from a reading specialist.
- The elementary gifted program will have to be redesigned, including less pull-out instruction and potential restructuring of grade level delivery.
- Dedicated case coordinators are reduced at the secondary level, shifting some special education responsibilities to other employees and administrators.

# Questions & Comments

## Phase 1 Reductions — \$750,000



Reduction Item	Estimated Cost Reduction	Description
Central Office Positions (3)	\$300,000	Elimination of one Central Office Administrator and two Central Office certified staff positions
Secondary Certified Staff (3)	\$243,000	Elimination of three teaching positions (ELA, Science and World Language)
Elementary Certified Staff (2)	\$162,000	Elimination of English as a Second Language teacher and Reading Specialist
Building Budgets	\$15,000	Each building will implement a 2.5% reduction in its overall budget
Summer School Staff	\$20,000	Reduction of staff members
Preschool Tuition Increase	\$9,900	FHSD Preschool Tuition is increasing \$308 per student

## Phase 2 Reductions — \$1.8 million



Reduction Item	Estimated Cost Reduction	Description
Certified Positions	\$1,100,000	Reduction of 15 certified staff positions
Pay-to-Participate Fees	\$344,000	Increase Pay-to-Participate fees for athletics/band by \$125 per student, per activity. Band would be \$300, AHS/THS athletics would be \$300, NMS athletics would be \$250.  Add \$175 Pay-to-Participate fee for theater
Transportation	\$400,000	Reduction of bus operators, routes and corresponding maintenance/fuel costs  District-wide changes to pick-up/start times of up to 30 minutes per building to accommodate fewer routes  Offsetting start times at elementary buildings  Disruption to shared programs like music, arts, band etc.  Fewer opportunities for elementary staff to align curriculum

### Phase 2 Certified Reductions (if necessary)



Subject Area/Role	Impact
Case Coordinators - Secondary (2 positions)	Less responsive oversight to special education programs and services. Impact on other administrative responsibilities (discipline and supervision, testing, scheduling etc.) that may not receive the same level of attention.
Gifted Specialists - Elementary (3 positions)	Three remaining Gifted Specialists will support two buildings each. Pull-out Gifted instruction will happen less often across all elementary schools with potential reduction in grade level model.
Media Specialists - Elementary (3 positions)	Reduced certified instructional time related to media, innovation, STEM and digital citizenship. The three reductions are offset by support roles needed to supervise students on a rotation model.
Music Education - K-12 (1 position)	Reduced opportunities for instruction in music performance at the elementary level. Impact on class sizes, course offerings in music programs at the secondary level.
Reading Specialists - Elementary (3 positions)	Reduced access to reading intervention for students. Increased caseload for remaining Reading Specialists.
<b>Teaching Positions</b> - Secondary (3 positions)	Increase in average class size for math, social studies and world language courses at both high schools. Some teachers will need to travel between AHS and THS to balance offerings.
